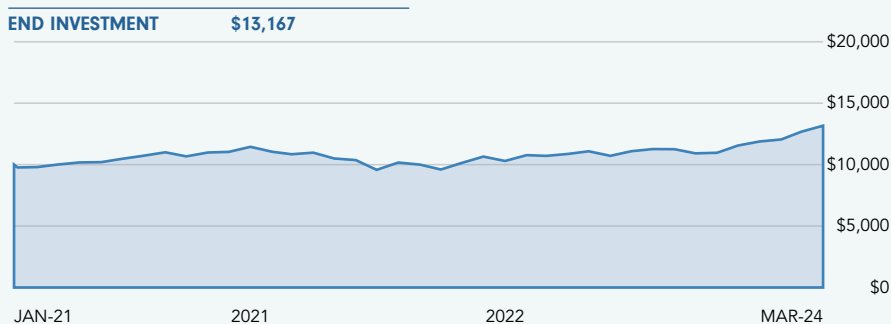

The more variable the returns, the larger the standard deviation.
