## **Management Discussion of Fund Performance**

### **Results of Operations**

Fidelity Balanced Class Portfolio ("Class") invests substantially all of its assets in units of underlying Fidelity Funds.

Fidelity Balanced Class Portfolio, Series B, returned 5.7%, after fees and expenses, for the six-month period ending May 31, 2011. The net returns of the other series of this Class are similar to those of Series B, except for differences attributable to expense structures. By way of comparison, the S&P/TSX Composite Index, broadly representative of Canadian equities, returned 7.9%. The Class' underperformance of the broad-based benchmark was primarily due to exposure to Canadian and global bonds, which was in line with the Class' mandate.

The Class' benchmark, the Fidelity Balanced Portfolio Benchmark, returned 6.6% for the six-month period under review. The Class' underperformance of the benchmark was primarily attributable to security selection among Canadian value and U.S. equities. At the end of the period, the Class had exposures of approximately 9.9% to Canadian value equities and 10.0% to U.S. equities, which was in line with the benchmark weightings.

The Fidelity Balanced Portfolio Benchmark is a blended index composed of approximately 12.5% S&P/TSX Capped Composite Index, 12.5% S&P/TSX Completion Index, 10% S&P 500 Index, 7% MSCI Canada Value Capped Index, 26% DEX Universe Bond Index, 5.5% Barclays Capital Global Aggregate Bond Index – Hedged CAD, 5% BofA Merrill Lynch US High Yield Master II Constrained Index – Hedged CAD, 10% MSCI All Country World ex U.S. Index, 4% MSCI World High Dividend Yield Index, 5.5% FTSE EPRA/NAREIT Developed Index and 2% of a blend made up of 80% allocations to four S&P/TSX industry groups (telecommunication services, utilities, oil and gas storage and transportation, and REITs) and a 20% allocation to the S&P BMI U.S. REIT Index – Hedged CAD.

Canadian equities gained during the six-month period ending May 31, 2011. The economic recovery in Canada continued at a moderate pace, despite showing slight weakness in economic activity. The economy expanded by 3.9% on an annualized basis in the first quarter of 2011, after businesses replenished inventories, increased investment spending and exports rose. However, the Bank of Canada maintained its target for the overnight rate at 1.0% during the period as the economic recovery continues broadly as expected and underlying inflation is relatively subdued. In May, conservatism prevailed as market participants grew uncertain about the direction of the markets, given the imminent approach of the end of the current quantitative easing program in the U.S. In addition, continuing sovereign debt concerns in Europe and signs that manufacturing activity in key economies may be slowing did little to ease matters.

At the end of the six-month period ended May 31, 2011, the asset allocation was as follows: 35.0% Canadian equity funds, 10.0% U.S. equity funds, 10.1% international equity funds, 5.0% global equity funds, 5.0% global real estate funds, 24.9% Canadian fixed-income funds, 5.0% global fixed-income funds and 5.0% U.S. high-yield funds.

Fidelity Balanced Class Portfolio is one of a suite of six multi-asset class portfolios designed to offer investors a diversified investment option in a single product, with low to moderate risk, that uses a balanced approach. The Class' targeted neutral mix is 65% equity investments and 35% fixed-income investments. The Class is managed with a view to maintaining consistent risk and return characteristics, and accordingly maintains an asset allocation balance close to its neutral mix. Portfolio design, construction and ongoing monitoring and management are conducted by portfolio managers Mark Friebe and Mariana Egan. The Class is monitored and actively managed on a daily basis to ensure that it adheres to its mandate. During the period under review, there were no significant changes in the Class' asset allocation to various equity and fixed-income funds, consistent with the Class' construction and management approach.

### **Recent Developments**

Portfolio co-managers Mark Friebe and Mariana Egan continued to monitor and adjust the Class' asset mix to achieve high total investment return. The Class' neutral asset mix is reviewed and reassessed on a quarterly basis using a robust proprietary quantitative and qualitative process of assessment. The purpose of this review is to ensure that the Class' asset mix is optimized to meet its fundamental investment objective and to confirm that the Class' targeted risk and return characteristics remain consistent. The portfolio managers invest in underlying Fidelity Funds that invest primarily in a mix of equity securities and fixed-income securities. During the period under review, Canadian equity funds accounted for the largest share of Class' assets, followed by Canadian fixed-income funds.

### **Independent Review Committee**

Susan E.C. Mey retired from the Independent Review Committee on February 23, 2011, and Helen Meyer was appointed on the same date for a term of three years.

### **Accounting Standards**

#### *Changeover to International Financial Reporting Standards*

The Canadian Accounting Standards Board (AcSB) of the Canadian Institute of Chartered Accountants (CICA) had planned to adopt International Financial Reporting Standards (IFRS), as published by the International Accounting Standards Board, effective January 1, 2011. In January 2011, the AcSB deferred the adoption of IFRS for investment companies, which include investment funds. Investment companies may continue to apply existing GAAP standards until fiscal years beginning on or after January 1, 2013.

The manager is reviewing and developing a plan to meet the above timetable for changeover to IFRS. The impact of IFRS on accounting policies and implementation decisions will mainly be in the areas of presentations and disclosures in the financial statements of the Class. Currently, two significant areas that may impact the presentation are IAS 32 Financial Instruments: Presentation, and IAS 27 Consolidated and Separate Financial Statements. The manager is currently assessing the Class' shareholder structure and investments to determine the impact of these standards. The manager has currently not identified any changes that will impact net asset value per share (NAVPS) as a result of the changeover to IFRS. However, this present determination is subject to change resulting from the issuance of new standards or new interpretations of existing standards.

## **Related Party Transactions**

### **Manager and Portfolio Adviser**

The Class is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is a wholly-owned subsidiary of FMR LLC. FMR LLC is the parent company of a group of subsidiaries collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Class in its day-to-day operations, including providing or arranging the provision of investment advice, establishment of brokerage arrangements relating to the purchase and sale of the investment portfolio, bookkeeping, record-keeping and other administrative services for the Class.

The Class' portfolio adviser is Fidelity and it provides investment advisory services to the Class.

As a result of providing investment advisory and management services, Fidelity receives a monthly management fee, based on the average net assets of each Series, calculated daily and payable monthly. The Class paid Fidelity management fees of \$1,835,000 for the period ended May 31, 2011.

### **Administration Fee**

Fidelity charges the Class a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Class, other than certain specified class costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Class pays an annual rate, which is calculated on a tiered basis, based on the average net assets of each Series. The Class paid Fidelity administration fees of \$256,000 for the period ended May 31, 2011.

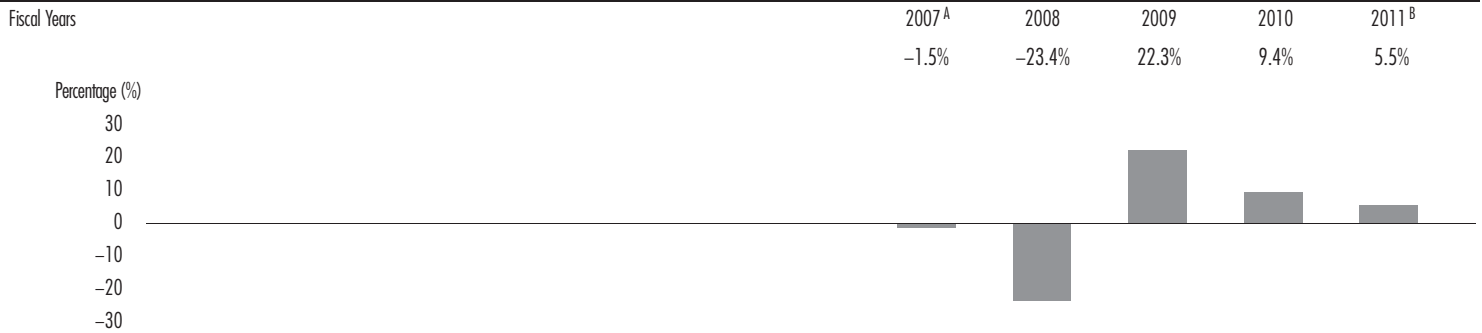

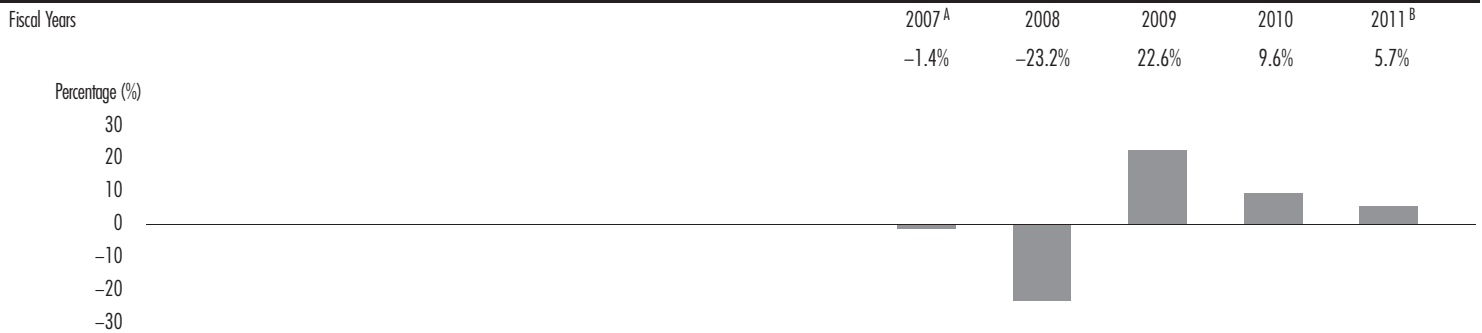

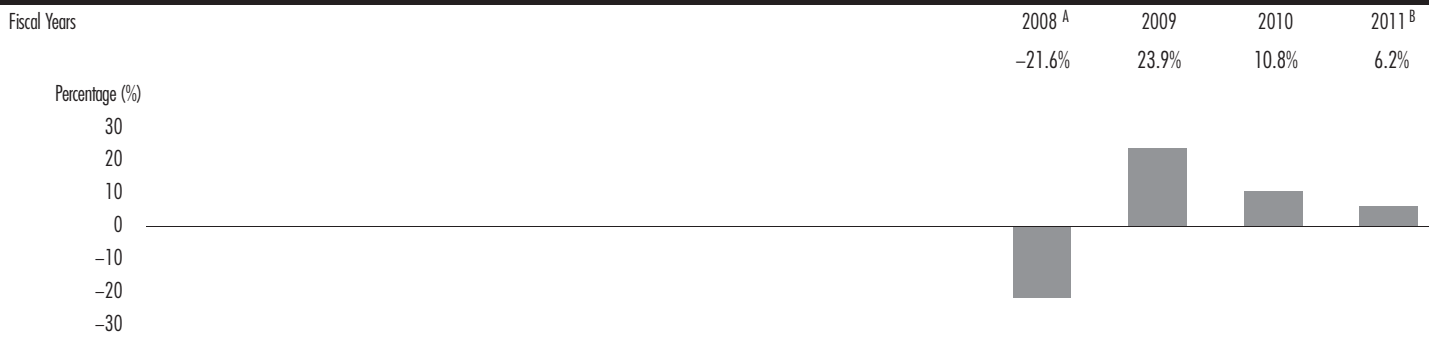
