The Simplified Prospectus is being amended to reflect a change to the financial year end of the Fund.

All capitalized terms used but not defined in this Amendment No. 3 have the respective meanings set out in the Simplified Prospectus.

AMENDMENT TO THE SIMPLIFIED PROSPECTUS

The technical amendment to the Simplified Prospectus required to effect this amendment is set out below:

Responsibility for administration of the Funds

The third paragraph under the sub-heading “Remuneration of Directors, Officers and Trustee” on page 16 is deleted and replaced with the following:

“Fidelity Multi-Sector Bond Multi-Asset Base Fund has a financial year end of March 31. Fidelity Emerging Markets Opportunities Fund, Fidelity Global Opportunities Long/Short Fund, Fidelity American High Yield Multi-Asset Base Fund and Fidelity American High Yield Currency Neutral Multi-Asset Base Fund have a financial year end of June 30.”

PURCHASER'S STATUTORY RIGHTS

Securities legislation in some provinces and territories gives you the right to withdraw from an agreement to buy mutual funds within two business days of receiving the simplified prospectus or fund facts, or to cancel your purchase within 48 hours of receiving confirmation of your order.

Securities legislation in some provinces and territories also allows you to cancel an agreement to buy mutual fund securities and get your money back, or to make a claim for damages, if the simplified prospectus, fund facts or financial statements misrepresent any facts about the fund. These rights must usually be exercised within certain time limits.
