The Simplified Prospectus is being amended to provide notice to investors that Maura Walsh and John Carolan will be replacing Michael Widrig as lead manager and co-manager of the Funds, respectively, following Mr. Widrig’s retirement at the end of this year. The amendments to the Simplified Prospectus are effective January 1, 2023.

## AMENDMENTS TO THE SIMPLIFIED PROSPECTUS

The technical amendments to Part A of the Simplified Prospectus required to effect these amendments are set out below:

### **Part A**

#### 1. Responsibility for administration of the Funds

### **PURCHASER'S STATUTORY RIGHTS**

Securities legislation in several of the provinces and territories gives you the right to withdraw from an agreement to buy securities within two business days after you receive a simplified prospectus or fund facts, or to cancel your purchase within 48 hours after you receive confirmation of a securities purchase. If you buy securities under a contractual plan, the time period for your right to withdraw from the purchase may be longer.

In several provinces and territories, securities law also gives you the right to cancel a purchase or, in some jurisdictions, claim damages if the simplified prospectus, annual information form, fund facts or financial statements contain a misrepresentation. You must act within the time limit set by the securities legislation in your province or territory.
