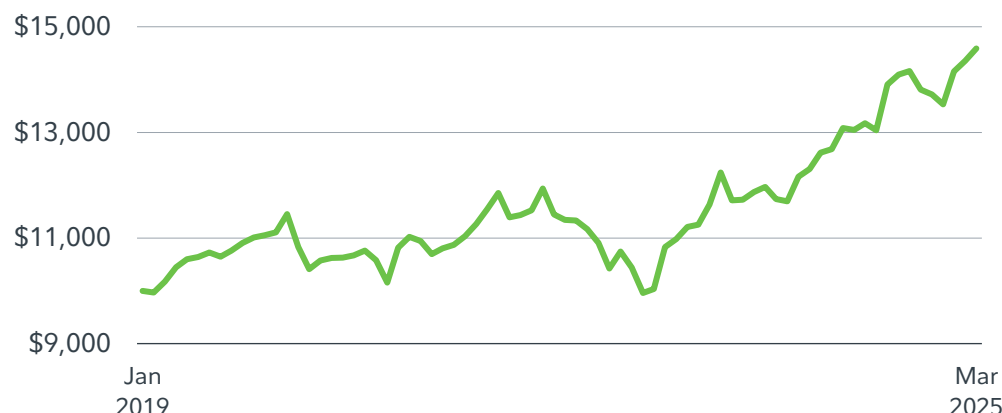
## Why invest in this ETF?

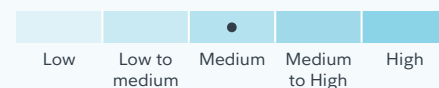

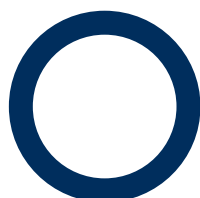

### Asset mix (%)



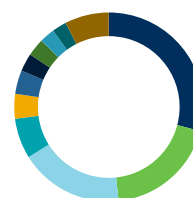
