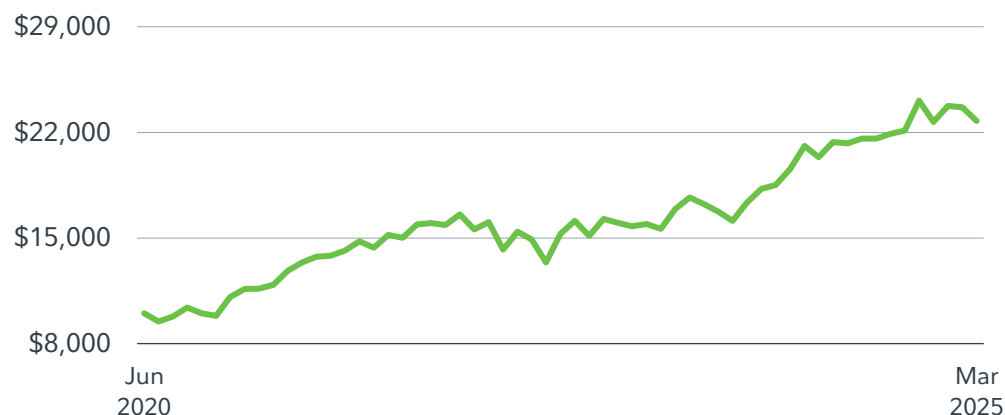

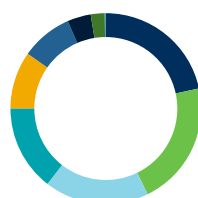

Currency Neutral ETFs use derivatives to mitigate the Fund's exposure to changes in exchange rates between developed market currencies and the Canadian dollar. The investment approach used by the ETFs, while effective in reducing exchange rate risk, will not completely eliminate the impact of currency fluctuations. The ETF's returns will differ from the local currency returns of its underlying ETF.
