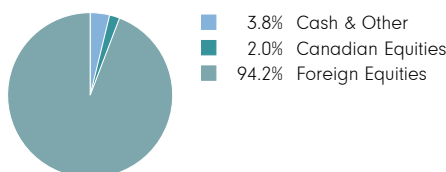

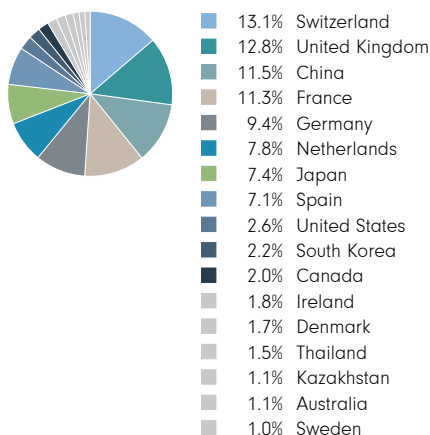

Pool management

- The Pool is constructed to be concentrated and diversified.
