## Management Discussion of Fund Performance

### Investment Objective and Strategies

**Investment Objective:** Fidelity Japan Class (Fund) aims to achieve long-term capital growth and seeks a return similar to that of Fidelity Japan Fund (Underlying Fund), by investing substantially all of its assets in securities of the Underlying Fund. The Underlying Fund, also managed by Fidelity, aims to achieve long-term capital growth by investing primarily in equity securities of Japanese companies.

**Strategies:** When buying and selling securities for the Underlying Fund, the portfolio manager examines each company's potential success by assessing its current financial condition and industry position, as well as economic and market conditions. The portfolio manager considers factors such as growth potential, earnings estimates and quality of management. The Underlying Fund may invest in small, medium and large companies, may hold cash, and invest in fixed-income securities.

### Risk

The risks associated with investing in this Fund remain as discussed in the prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund is suitable for long-term investors who want to gain exposure to Japanese companies, and can handle the volatility of returns generally associated with equity investments. Registered plan investors should be aware that the Fund may, from time to time, bear an income tax expense which will reduce returns. To invest in the Fund, investors should be willing to accept a medium level of risk. The suitability of the investment has not changed from what has been disclosed in the prospectus.

### Results of Operations

Fidelity Japan Class, Series B, returned 20.2%, after fees and expenses, for the twelve-month period ended November 30, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, global equities, as represented by the MSCI World Index, returned 32.0% (in Canadian dollar terms).

#### Market overview:

Global equities, as broadly measured by the MSCI World Index, returned 32.0% in Canadian dollar terms and 27.8% in U.S. dollar terms, for the one-year period ended November 30, 2024.

Global equities advanced for the period under review. Falling interest rates in major developed markets, decreasing inflation, and positive U.S. economic data, helped support investor confidence. Investor optimism in the digital innovation and artificial intelligence space helped fuel growth in the information technology and communication services sectors, propelling the technology-heavy NASDAQ Index to record highs. However, investor sentiment shifted later in the review period due to concerns about stretched valuations and relatively weaker U.S. economic growth. Valuations of companies in the financials sector rose, signalling optimism about potential earnings growth from reduced borrowing costs. Defensive sectors, such as utilities and consumer staples, also gained as investors looked for stability amidst ongoing market volatility. In Europe, equities surged despite some volatility along the way. Markets recovered as the European Central Bank implemented rate cuts, and China's central bank embarked on its most significant stimulus since the pandemic, in effort to ease the deflationary cycle. Japanese equities experienced volatility, amid shifting monetary policy expectations. The interest rate hike by the Bank of Japan led to a rapid unwinding of leveraged global trades, which created market volatility.

#### Factors affecting performance:

The Fund underperformed its broad-based benchmark, the MSCI World Index, primarily due to the Underlying Fund's investments in the information technology and consumer discretionary sectors.

The Fund's benchmark, the Tokyo Stock Price Index (TOPIX), returned 17.4% for the review period. The Fund outperformed its benchmark, primarily due to the Underlying Fund's exposure to certain stocks in the industrials sector. In the sector, investments in Japan-based diversified industrial conglomerates Mitsubishi Heavy Industries and Hitachi contributed to relative returns. Exposure to certain stocks in the consumer discretionary sector also contributed to relative returns. In this sector, an investment in Japan-based retail firm Fast Retailing, and lack of exposure to a Japan-based automotive manufacturer, both contributed to relative returns. In other sectors, investments in Japan-based banks financial holding firms Mitsubishi UFJ Financial Group and Sumitomo Mitsui Financial Group contributed to relative returns.

In contrast, investments in certain stocks in the information technology sector detracted from relative returns. In the sector, investments in Japan-based software testing firm SHIFT, and Japan-based semiconductor firm Lasertec Corporation, detracted from relative returns. Investments in certain stocks in the consumer staples sector also detracted from relative returns. In that sector, investments in Japan-based food firm Nissin Foods Holdings, and Japan-based beverage firm Asahi Group Holdings, detracted from relative returns. In other sectors, investments in Japan-based automotive manufacturers Denso, and Japan-based management consulting firm BayCurrent, detracted from relative returns.

At the end of the review period, the Underlying Fund had no exposure to SHIFT, Lasertec Corporation, Nissin Foods Holdings or BayCurrent.

#### Portfolio changes:

During the review period, the Underlying Fund's exposure to the financials and communication services sectors was increased. In the financials sector, the portfolio manager increased exposure to Mitsubishi UFJ Financial Group. In the communication services sector, a position was initiated in Japan-based video game firm Nintendo.

In contrast, exposure to the information technology and consumer staples sectors was decreased. In the information technology sector, the portfolio manager exited the position in SHIFT. In the consumer staples sector, the position was exited in Nissin Foods Holdings.

At the end of the review period, the Underlying Fund had its largest absolute exposure to the consumer discretionary sector, followed by the industrials sector. The Underlying Fund diverged most from its benchmark's sector weightings by having more exposure to the consumer discretionary sector and less exposure to the communication services sector.

### **Recent Developments**

Portfolio manager Eileen Dibb is positive on Japan's equities as the economy transitions into a mildly inflationary state, following decades of stagnant growth and falling prices. The portfolio manager believes wage increases will have a knock-on effect of boosting consumption and supporting further price gains. At the same time, the portfolio manager believes corporate governance reforms in Japan continue to unlock equity market value, and companies may focus more on dividends and buybacks. As a result, in the portfolio manager's view, the shareholder return profile of Japanese companies may improve faster than most other developed markets. Against this backdrop, the portfolio manager continues to seek structurally competitive companies that the manager believes are consistently growing, with potentially improving returns to shareholders, as well as companies the manager believes appear inexpensively valued and are expected to recover.

### **Related Party Transactions**

#### **Manager and Portfolio Adviser**

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day-to-day operations, bookkeeping, record-keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$339,000 for the period ended November 30, 2024.

#### **Administration Fee**

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$59,000 for the period ended November 30, 2024.

### **Independent Review Committee, Cross-Trading and In specie Transactions**

#### **Independent Review Committee**

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at [www.fidelity.ca](http://www.fidelity.ca) or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

#### **Cross-Trading and In specie Transactions**

The Fund received the approval and standing instructions from the IRC in order to:

- (i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;
- (ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

- <sup>B</sup> Net assets and distributions are based on the actual number of securities outstanding at the relevant time. The increase (decrease) from operations is based on the weighted average number of securities outstanding over the financial period. This table is not intended to be a reconciliation of beginning to ending net assets per security.
- <sup>C</sup> Distributions were paid in cash or reinvested in additional securities of the Fund, or both, and excludes any applicable distributions of management fee reduction to securityholders.
- <sup>D</sup> This information is provided as at period end of the year shown.
- <sup>E</sup> Prior period amounts may have been adjusted.
- <sup>F</sup> Management expense ratio is based on total expenses (excluding distributions, commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of daily average net asset values during the period, including the Fund's pro-rata share of estimated expenses incurred in any underlying investment fund, if applicable.

- <sup>I</sup> The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate includes any proceeds from a short sale in the value of sales of securities and the cost of covering a short sale in the value of purchases of securities. For periods greater than six months, but less than a full fiscal year, the portfolio turnover rate is annualized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

## Management and Advisory Fees

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.

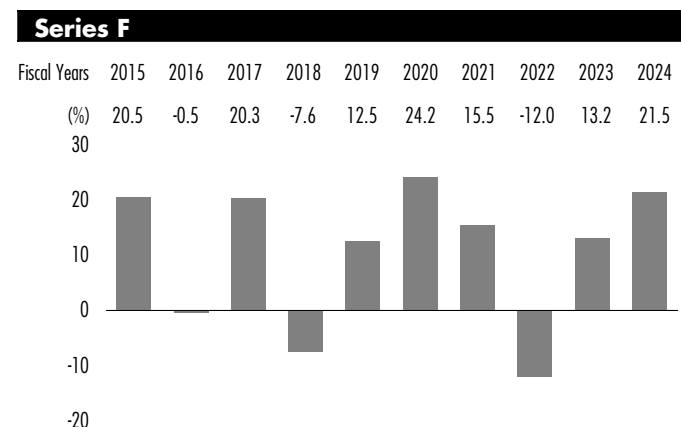
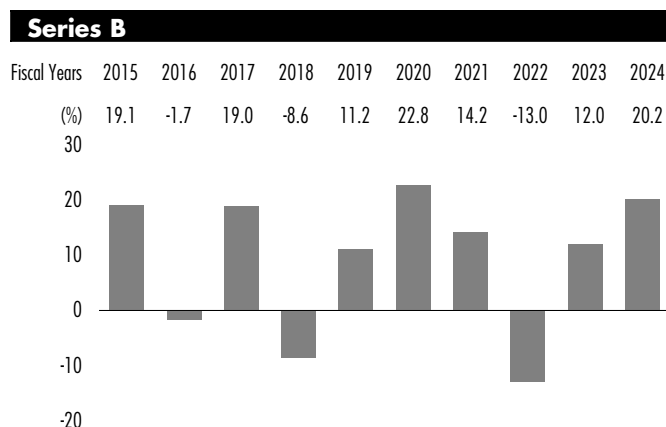
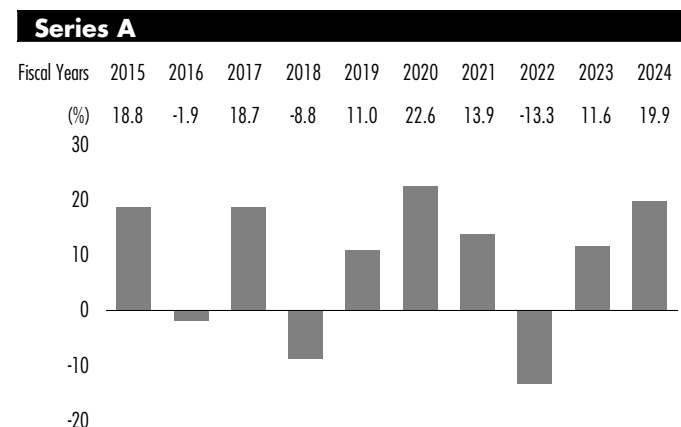
