

**AMENDMENT NO. 1**

**to the Annual Information Form of Fidelity Funds dated September 18, 2020**

**(the “AIF”)**

**in respect of:**

**Series A, B, E1, E2, E3, F, F5, F8, O, P1, P2, P3, S5, S8, T5, T8 units of  
Fidelity Long-Term Leaders Fund**

**(the “Fund”)**

The Annual Information Form is being amended to add Series E1T5, E2T5, P1T5, P2T5, P3T5 and P4 units to the Fund.

## AMENDMENTS TO THE AIF

The technical amendments to the AIF required to effect these amendments are set out below:

### 1. Front Cover and Back Cover

The front and back covers are amended to indicate the following:

- (a) Series E1T5, E2T5, P1T5, P2T5, P3T5 and P4 units are also available for the Fund.

### 2. The Fidelity Funds

- (a) The third and fourth paragraphs under the heading “The Fidelity Funds” on page 2 are deleted and replaced with the following:

“The Funds are available in up to twenty-two (22) series of units as specified on the cover page: Series A, B, E1, E2, E3, E1T5, E2T5, F, F5, F8, O, P1, P2, P3, P4, P1T5, P2T5, P3T5, S5, S8, T5 and T8. Series A, B, S5, S8, T5 and T8 units of the Funds are available to all investors. Series E1, E2, E3, E1T5, E2T5, F, F5, F8, O, P1, P2, P3, P4, P1T5, P2T5 and P3T5 units are available only to certain investors who are eligible for those series.

Series E1, E2, E3, E1T5 and E2T5 are collectively referred to as “**Series E**”. Series P1, P2, P3, P4, P1T5, P2T5 and P3T5 are collectively referred to as “**Series P**”.”

### 3. Income Tax Considerations

- (a) The second sentence in the second paragraph under the subheading entitled “Taxation of Unitholders (other than Registered Plans)” on page 43 is deleted and replaced with the following:

“Monthly distributions on units of some of the Funds and certain Series of the Funds (such as Series E1T5, E2T5, F5, F8, P1T5, P2T5, P3T5, S5, S8, T5 or T8 units) are expected to include a return of capital.”
