- (iii) notify investors of the re-opening of Fidelity International Disciplined Equity[®] Currency Neutral Class for investor purchases on or around December 11, 2020; and
- (iv) notify investors that Fidelity Corporate Bond Class will continue to remain generally closed to new purchases and switches.
