

## **AMENDMENT NO. 5**

**dated August 6, 2019**

**to the Annual Information Form of Fidelity Funds dated November 1, 2018, as amended by Amendment No. 1 dated November 28, 2018, Amendment No. 2 dated December 21, 2018, Amendment No. 3 dated January 9, 2019 and Amendment No. 4 dated April 1, 2019**

**(the “AIF”)**

**in respect of:**

**Series O units of Fidelity Insights Investment Trust**

**(the “Fund”)**

The AIF is being amended to permit Series O units of Fidelity Insights Investment Trust to be purchased by any investor approved by us that has entered into a Series O fund purchase agreement with Fidelity Investments Canada ULC.

### **AMENDMENT TO THE AIF**

The technical amendments to the AIF required to effect this amendment are set out below:

1. **The Fidelity Funds**

- (a) The fifth sentence in the third paragraph under the heading “The Fidelity Funds” on page 2 is deleted and replaced with the following:

“Units of Fidelity American Disciplined Equity<sup>®</sup> Currency Neutral Fund, Fidelity Global Disciplined Equity<sup>®</sup> Currency Neutral Fund, Fidelity International Disciplined Equity<sup>®</sup> Currency Neutral Fund, Fidelity NorthStar<sup>®</sup> Currency Neutral Fund (collectively, the “Equity Currency Neutral Funds”) and the Investment Trusts are only available in Series O and, with the exception of Fidelity Global Intrinsic Value Investment Trust, Fidelity Insights Investment Trust and Fidelity Global Growth and Value Investment Trust, are not available for public purchase. Series O units of Fidelity Global Intrinsic Value Investment Trust, Fidelity Insights Investment Trust and Fidelity Global Growth and Value Investment Trust are also available for purchase by any investor approved by us that has entered into a Series O Fund Purchase Agreement with us.”

2. Purchases and Switches of Units

- (a) The second sentence in the twelfth paragraph under the subheading entitled “Switching Series E and P Units” on pages 35 and 36 is deleted and replaced with the following:

“Series O units of the Investment Trusts (other than Fidelity Global Intrinsic Value Investment Trust, Fidelity Insights Investment Trust and Fidelity Global Growth and Value Investment Trust) and the Equity Currency Neutral Funds (other than Fidelity U.S. Dividend Currency Neutral Fund, Fidelity Global Concentrated Equity Currency Neutral Fund and Fidelity International Concentrated Equity Currency Neutral Fund) are only available for purchase by the Fidelity Funds and other funds and accounts managed or advised by Fidelity and are not available for public purchase.”

- (b) The second sentence in the fifth paragraph under the subheading entitled “Switching Units to another Fidelity Fund” on page 36 is deleted and replaced with the following:

“Series O units of the Investment Trusts (other than Fidelity Global Intrinsic Value Investment Trust, Fidelity Insights Investment Trust and Fidelity Global Growth and Value Investment Trust) and the Equity Currency Neutral Funds (other than Fidelity U.S. Dividend Currency Neutral Fund, Fidelity Global Concentrated Equity Currency Neutral Fund and Fidelity International Concentrated Equity Currency Neutral Fund) are only available for purchase by the Fidelity Funds and other funds and accounts managed or advised by Fidelity and are not available for public purchase.”

3. Fees and Expenses

- (a) The first sentence in the first paragraph under the subheading entitled “Series O Units” on page 171 is deleted and replaced with the following:

“Series O units of the Investment Trusts (other than Fidelity Global Intrinsic Value Investment Trust, Fidelity Insights Investment Trust and Fidelity Global Growth and Value Investment Trust) and the Equity Currency Neutral Funds (other than Fidelity U.S. Dividend Currency Neutral Fund, Fidelity Global Concentrated Equity Currency Neutral Fund and Fidelity International Concentrated Equity Currency Neutral Fund) are not available for public purchase.”

- (b) The following is added after the last sentence in the second paragraph under the subheading entitled “Series O Units” on page 171:

“Series O units of Fidelity Global Intrinsic Value Investment Trust, Fidelity Insights Investment Trust and Fidelity Global Growth and Value Investment Trust

are also available for purchase by the Fidelity Funds and other funds and accounts managed or advised by Fidelity. There is no management fee payable by the Fidelity Funds or such other funds with respect to these Series O units of this Fund.”
